As some of you know, we had 4 Green Valley Firemen speak at our October Potluck. I decided to do the smoke alarm battery program, GVFD will come to your house and change all the batteries once a year for \$20.00 When they checked my smoke alarms, they were found defective. They were the original alarms and were installed in 1999. One of the men said that smoke alarms should be replaced every ten years. He recommended BRK smoke alarms – ac powered - with battery back-up. I found them at Ace Hardware for \$15.99 each. The 2 men came and left while I went to Ace to buy the smoke alarms and after returning home, I called them and they came back (after taking care of a snake call) and installed the new smoke alarms. The only charge was the \$20.00.

This is a great service by our Fire Dept. and one that I think all residents should consider. Green Valley Fire District Smoke Alarm Battery Program (393-7505)

BOARD MEETING SUMMARY

(November, 2013)

- Bill Perry is taking over the pot luck program.
- Sandie Stone is attending the traffic and arroyo meetings to keep up on the expansion possibilities of the widening of the frontage road to the south end near the hospital to Canoa Rd. The concern is for the safety due to the amount of traffic and speed of those using the frontage road, especially for exiting vehicles from the Springs.

- The grounds committee reported the javalina have been rooting in Perry Park and the best deterrent is moth balls.
- The wood chipper has been working well for the grounds volunteers.
- The ARC has had 31 requests in 2013.
 27 completed 4 in process. Painting and staining of homes had 12 completed this month, 83 in process and 15 past due.
- The rumble strips will be installed near the exit.
- The new controller for the gate is in and a remote maybe purchased for \$20 or you can borrow a loaner remote to train the opener on your vehicle. The code will be the same for those who stop and punch the code in.
- Tucson Electric will be modifying the street lights to direct the light downward and reduce the lateral dispersion. This should help for those who had light coming into their homes from the street lights.
- The budget was discussed and approved. The 2014 dues will be \$485.

GVR Update

Busy times for the GVR Board! During the first three weeks of November, it has been a nearly full time job, but with what has been accomplished, things should settle down for awhile.

On November 11, we elected 4 candidates to join the board, bringing us to full strength. I felt pleased with the choices, and believe these folks will be positive additions, as they are articulate, thoughtful, and appear not to have any agendas other than to serve the well being of our organization.

Next, we were able to pass the budget for 2014. The budget represents a reasonable compromise between spending cuts and revenue enhancements, as I outlined last month. For members, dues will increase \$19 to \$440, a 4.5% increase. Present services and maintenance should be preserved under this budget.

On November 13, the board selected Kent Blumenthal to serve as the next CEO for GVR. This followed a nation wide search that attracted nearly 100 applicants. Kent has a doctorate in recreation management and lengthy experience in areas highly transferable to leading GVR. He intends to move here from Corvallis, Oregon in January, and we plan to hold a reception for him where members can meet him and offer well wishes. Kent has studied our organization extensively, and is very personable, so I urge you to come meet him. The date of this event will be announced soon. I served on the search committee beginning in August, and feel very optimistic about the hiring of Kent.

On the downside, our organization continues to be dogged by a small group of naysayers who spend their time and energy micro-managing the Board. Their behavior is destructive. demoralizing and in no way represents the feelings of the members they claim they speak for. The local press feeds off the negativity these folks supply them with. I truly believe that the very vast majority of our membership is pleased with what GVR brings to their lives, and finds it to be a good bargain. We don't hear from these folks as they are too busy enjoying life in Green Valley. I would point out, that when this small negative group is able to paint us as a dysfunctional, untrustworthy, and over priced organization, it tarnishes the reputation of the community and de-values our property. Moral of the story: take what you read in the letters and columns in the newspaper with large grains of salt. Hopefully, with new leadership we can get the more positive vibes we deserve.

Death and Taxes and...

Ben Franklin wrote in a 1789 letter: "... in this world nothing can be said to be certain, except death and taxes". If he were writing that letter today he might add "and dues increases." Two of Green Valley's non-profit corporations have approved almost identical increases in their annual fees. They are of course Green Valley Recreation (GVR) and the Springs at Santa Rita Homeowners Association (your HOA).

Both organizations are on a similar path. Their physical facilities are aging and in need of repairs and additional maintenance, growth in paying members has stopped or slowed, and the number of volunteers is less than is needed. In the years when both organizations were increasing in membership because of new homes being built, revenue kept increasing and facilities were new. Now the only source of new revenue is from the current members. Containing costs is difficult because old facilities have more repair and maintenance costs. Every organization will try to put positive spin on unpopular decisions. GVR Finance Director Kim Akers announced a dues increase to \$440 for next year, and stated that dues should be an additional \$20 higher if they were in line with the consumer price index. The HOA is increasing our annual fee by \$20. The HOA has averaged only an annual 1.7% increase over the last eight years; and four of those years there were no increases. But the bottom line is that expenses for critical functions are increasing faster than income. Volunteers could reduce some of this cost increase, but this resource seems to be in

decline too. Perhaps both organizations were too conservative in their increases in the past..."you can pay me now, or you can pay me later." Both organizations have a finance committee to help review financial issues. This year, both organizations reviewed multiple options before making their final decisions. New CEOs Coming to Green Valley

At about the same time, one of Green Valley's oldest organizations and one of it's newest corporations named new leaders. Green Valley Recreation (GVR), which was created in 1978 from the merger of two previous neighborhood recreation organizations, named Kent Blumenthal as its new Executive Director. Dr. Blumenthal has a strong academic background in Parks and Recreation. Not the TV show but a real Ph.D. in Parks and Recreation Administration from the University of Maryland. He has thirty-five years of leadership experience with two large national organizations, the National Recreation and Parks Association (NRPA) and the National Intramural-Recreational Sports Association (NIRSA). NIRSA proclaims to be a leader in higher education and the advocates for the advancement of recreation, sport, and wellness by providing educational and developmental opportunities. NIRSA has adopted the tagline, Leaders in Collegiate Recreation, which clearly indicates their aim to provide models for excellence in the collegiate recreation profession. After his 2012 departure from NIRSA to continue his professional and personal growth and to pursue other interests, Dr. Blumenthal formed his own executive consulting company, Blumenthal and Associates. He hasn't started his job yet, but he will probably get a promotion. GVR Board President Blaine Nisson has stated that the board plans to change the by-laws to upgrade the executive director to CEO. (I guess there wasn't a pay raise, so upgrade the title.)

GVR could be a challenge for Blumenthal. Although he brings a strong academic and experiential background, GVR is a communitybased program and much smaller than the national focus he previously led. Maybe the collegiate focus of NIRSA will help him energize and revitalize Green Valley. Maybe you'll run into him at one of the centers, he regularly does cardio workouts and pumps iron.

The next new CEO to the area is David Wanger. McDowell Enterprises, the developer of the hospital site announced the selection of Wanger to lead the way through the business and compliance issues ahead. Mr. Wanger has previous history with McDowell. He was the first administrator of the Gilbert Hospital, which McDowell developed. The Gilbert facility opened in 2006 and has a service model closer to what Green Valley needs. It is primarily an outpatient and emergency facility. According to their statistics, the 19 bed partially physician owned facility has an average census of 10 patients. with 3 admissions per day and 3 surgeries per day. Each day the 21 room emergency department has more than 120 patients and claims having a minimal waiting time to receive treatment. Mr. Wanger has been listed as the CEO for Visionary Health LLC, a company that has developed hospitals including Peoria, Gilbert, and Florence. When he was CEO of Gilbert hospital, he also was CEO of Florence Hospital at Anthem which opened in early 2012. One year later it filed for Chapter 11. The hospital expected to treat inmates from the nearby correctional facility, but didn't agree on a contract with the state. Florence Hospital was also an EB5 foreign investor funded project like the Green Valley Hospital. The hospital recently canceled contracts with Aetna, Blue Cross and Blue Shield and HealthNet. The Peoria Regional Medical Center, which Mr. Wanger was involved with was planned to open in 2009, but construction was halted and remains unfinished. As late as June of this year, He was listed as CEO of Incepta Healthcare and was building a hospital in Sachse, Texas. Perhaps as an indication of a smaller service scope for our facility, the name has changed from Green Valley Medical Center to Green Valley Hospital, a limited liability for profit corporation. The "for Green Valley only" focus is also retreating, as plans for bariatric surgery and birthing services were announced, indicating plans for a more regional marketing effort. A website for the facility will be up soon to monitor the progress of construction, which is more than a year behind schedule.

Besides his leadership role at Gilbert, Mr.

Wanger has experience in New Jersey and California Hospitals. His academic background includes Economics and Political Science degrees from Rutgers University and an MBA in Healthcare Administration from Wagner College in New York. He also completed a hospital administration residency. When not developing hospitals, he is building his vacation home in Fiji.

We all welcome these two leaders to our community and offer our support for their efforts to improve significant portions of our lives. They are going to have a lot of challenges ahead and need our support to succeed.
